Pursuant to the Election Law, NMSA 1978, Sections 1-11-1 to 1-11-4 I, Linda J. Padilla, Rio Arriba County Clerk, by virtue of the authority vested in me, do hereby issue the following proclamation:

That a General Election shall be held throughout the County of Rio Arriba, state of New Mexico, and in each precinct thereof on November 6, 2018;
