ELECTION RESOLUTION

VILLAGE OF CHAMA

Resolution No. 2021-19

Be it resolved by the governing body of the Village of Chama that:

- A. A regular municipal election for the election of municipal officers shall be held on Tuesday March 1, 2022. Polls will open at 7:00 A.M. and close at 7:00 P.M.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices:
 1. ONE (Councilor, Trustee, Commissioner) for a four-year term.
 2. ONE (Councilor, Trustee, Commissioner) for a four-year term.
 3. ONE (Mayor) for a four-year term
 4. ONE (Municipal Judge) for a four- year term.
- C. Precincts 4 is consolidated for the regular municipal election.
- D. The following locations is designated as the polling place for the conduct of the regular municipal election:
 1. Voters in Precinct 4 shall vote at Chama Senior Center 2449 US Hwy 84-64, Chama, NM 87520
- E. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 4, 2022 between the hours of 8:00 A.M. and 5:00 P.M. at 1512 B State Highway 17, Chama NM 87520 (1-22-3.1E (3)
- F. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Rio Arriba County not later than Tuesday, February 1, 2022 at 5:00 P.M., the date on which the County Clerk will close registration books. (excludes same day voter registration at early voting locations) 1-4-8
- G. **Absentee Voting:** Applications for absentee ballots may be obtained only from the office of the Municipal Clerk 1512 B State Highway 17 Chama, NM 87520 or call

day to request an absentee ballot February 24,2022. Last day to mail out absentee ballots February 25, 2022. All applications for an absentee ballot must be completed and accepted by the Municipal Clerk prior to 5:00 p.m., March 1, 2022.

Absentee ballots may be marked in person in the office of the Municipal Clerk during the regular hours and days of business, beginning on February 1,2022 and closing at 5:00 p.m. on Tuesday March 1, 2022.

All unused absentee ballots will be publicly destroyed by the Absentee Board after 5:00 p.m. on March 1,2022. The Municipal Clerk will accept completed absentee ballots delivered in person by the voter casting the absentee ballot, by a member of the voter's immediate family, or by the caregiver to the voter until 7:00 p.m. on March 1, 2022.

Same Day Registration. Will be offered on Election Day.

Early Voting. Early voting on paper ballots counted by ICE electronic vote tabulator will be conducted in the office of the Municipal Clerk at 1512 B State Highway 17 Chama, NM 87520. February 1-25, 2022 Monday thru Thursday 8 a.m. to 5:00 p.m. and Saturday February 26, 2022 from 10:00 a.m. to 6:00 p.m.

- H. The casting of votes by qualified municipal electors shall be recorded on paper ballots to be counted by electronic vote tabulators. An ICE machine will be available for any handicap qualified municipal elector.
