Preparation and certification of all Election Day voting machines to be used for the Regular Local Election will take place on Friday, October 1, 2021, beginning at 9:00 a.m. and continuing on Saturday, October 2, 2021, until completed. Certification and preparation will take place at the **Clerk's Election Warehouse located at 714 Calle Don Diego, Española, New Mexico 87532**.

Pursuant to Chapter 1 NMSA 1978, Section 1-2-17. "Election Board; Schools of Instruction.", notice is hereby given that for the upcoming November 2, 2021, Regular Local Election there will be a precinct board school of instruction held for Voting Convenience Center's from 9:00 a.m. to 4:00 p.m. on Monday, October 4, 2021, and Tuesday, October 5, 2021, and from 5:00 p.m. to 8:00 p.m. on October 6, 2021. The school of instruction for rural precincts will be held on Wednesday, October 6, 2021, from 9:00 a.m. to 12:00 p.m. All schools of instruction will be held at the **Clerk's Election Warehouse located at 714 Calle Don Diego, Española, and New Mexico 87532**.

Pursuant to Chapter 1 NMSA 1978, Sections 1-13-1 through 1-13-8, the Rio Arriba County Clerk's Office will hold the canvass for the November 2, 2021, Regular Local Election at 3:00 p.m. on Tuesday, November 9, 2021, at the Tierra Amarilla Commission Chambers located at 7 Main Street, Tierra Amarilla, NM 87575.
